BY MAIL



**Request by Oct 22,
5 p.m.**

Request from your county. Sign the return envelope and track it. For most domestic voters, the ballot must be received by Nov 3 at 7 p.m.; a postmark is not enough.

EARLY VOTING



**CHECK YOUR
COUNTY**

Use an early-voting site in your county, not necessarily your Election Day precinct. Check dates and hours before traveling.

ELECTION DAY



**Nov 3 • 7 a.m.-7
p.m.**

Go to your assigned polling place. If you are in line at 7 p.m., stay in line. Bring accepted identification.

BRING CURRENT, VALID PHOTO + SIGNATURE ID



If your photo ID has no signature, bring another ID with your signature. A voter information card is not accepted ID. Florida accepts these photo IDs:

- Florida driver license
- Florida identification card
- U.S. passport
- Debit or credit card
- Military identification
- Student identification
- Retirement center ID
- Neighborhood association ID
- Public assistance ID
- VA health ID card
- Florida concealed weapon / firearm license
- Government employee ID

NO ACCEPTED ID? NEED ASSISTANCE?

Ask a poll worker about a provisional ballot if you do not have accepted ID. Accessible voting equipment and voting assistance are available. Contact your county before you go for accommodation details.

PALM BEACH COUNTY

Understand the Measures.

Read the official wording before deciding. These brief descriptions do not recommend a YES or NO vote.

01 BUDGET STABILIZATION FUND

STATE BUDGET RESERVES

Would increase the maximum reserve from 10% to 25% of general revenue collections, require annual transfers subject to stated conditions, and permit withdrawals for critical state needs.

02 AGRICULTURAL PERSONAL PROPERTY

TAX EXEMPTION

Would exempt qualifying tangible personal property used for agriculture or agritourism on agricultural land. If approved, it would first apply to tax years beginning January 1, 2027.

03 HOMESTEAD EXEMPTION / ASSESSMENT CAP

PROPERTY TAXES

Concerns a larger homestead exemption and a lower cap on annual increases in non-homestead property assessments. Read the official text for eligibility, timing, school-tax treatment, and local-government impacts.
